ACTIVITY: AOD - 1 - DATS-CDAOP-1 (24-25) CORE AOD AND OPERATIONAL

Activity Priorities and Description

PROGRAM KEY PRIORITY AREA

Alcohol and Other Drugs

AIM OF ACTIVITY

To increase access to, and the quality of, indigenous-specific alcohol and other drug prevention, care and treatment services across Western Queensland in collaboration with Aboriginal and Torres Strait islander Community Controlled Health Services (AICCHS) and other keys stakeholders.

DESCRIPTION OF ACTIVITY

Commission the provision of services by North West Remote Health (NWRH) in Doomadgee in 2024 - 2025, continue to support Gidgee Healing and other regional AICCHS, including supporting workforce capacity to provide alcohol and other drug services within a culturally-appropriate wider Social and Emotional Wellbeing (SEWB) model of care.

Continue to commission implementation of a Primary Care Telehealth-based Alcohol Detoxification service with Clean Slate Clinic through a clinical partnership with primary health practices, ACCHO and other related entities for home-based detox for suitable clients through established regional Recovery and Accommodation Centres. Clean Slate treatment to be delivered to a minimum 42 suitable persons across the WQPHN region (with 32 home detox clients and 10 residentially based).

Alongside other AOD-specific workforce capacity building support, refine and continue support for training and integration of the Menzies School of Health Research e-Mental Health Stay Strong application to increase screening, health coaching and goal setting within a stepped care referral construct, and to support team care arrangements, including; referral to Clean Slate Clinic home-based tele detox and out-of-region residential rehabilitation services; the Normanton Recovery Centre and/or Clean Slate Clinic for assessment for need/suitability for telehealth detox support and; promote wider wellbeing through General/Primary Practice and ACCHO pathways.

Coordinate with commissioned ACCHO partners and Menzies to offer training, integration and better use of the Stay Strong application (SSA) to support quality, consistency and alignment of SEWB/AOD programs across the WQPHN region, and linkage supported to stepped care approaches and integration of SSA with both the ACCHOS model of care and each agencies individual record keeping/reporting systems.

Continue to support a culturally sensitive service co-design process in collaboration with Gidgee Healing and First Nations Health Councils on Mornington Island and Doomadgee and enable alignment with the WQPHN Regional Mental Health & Suicide Prevention Plan, Nukal Murra Social and Emotional Wellbeing Framework and the Commissioning For Better Health Guide.

Activity Priorities and Description

PROGRAM KEY PRIORITY AREA

Alcohol and Other Drugs

AIM OF ACTIVITY

Co-design and implement Indigenous-specific AOD-focused support and care in collaboration with AICCHS that is integrated into their social and emotional wellbeing services to provide culturally appropriate support and care with Aboriginal and Torres Strait Islander communities and clients across the region.

DESCRIPTION OF ACTIVITY

Commission culturally competent and responsive AOD treatment support services through the implementation of the Nukal Murra Social and Emotional Wellbeing Framework and integration of the Menzies eMental health Stay Strong App (SSA) within a primary mental health model of stepped care.

Coordinate support and work with Nukal Murra Alliance members to ensure that commissioned drug and alcohol services are integrated within primary health systems including local stepped care approach through universal culturally appropriate methods, tools and assessments, low intensity support, including prevention, treatment and recovery support, and the enhanced management of dual diagnoses through team care and better access to specialist substance use disorder services.

Support Nukal Murra Alliance members to develop their capacity and confidence, and adopt referral pathways, to improve treatment, care coordination and recovery through better integration with wider social and cultural care provider networks.

Strengthen and enhance the workforce, including development and maintenance of relationships between mainstream and Aboriginal and Torres Strait Islander health services.

Activity Priorities and Description

PROGRAM KEY PRIORITY AREA

Alcohol and Other Drugs

AIM OF ACTIVITY

That people living in the WQPHN region with a direct or indirect substance use concern/issue or substance use disorder have access to both mainstream and Indigenous specific information and treatment services that are tailored to the community and their needs, and that foster earlier help seeking and reduce AOD-related stigma and discrimination.

DESCRIPTION OF ACTIVITY

Continue to work with specialist/accredited drug and alcohol treatment service providers to ensure integration with the primary health system with the goal to improve referral pathways, joined-up care and coordinated efforts between primary health care, specialist (e.g. substance use disorder) services and research/training institutes.

Support and expand the adoption of evidence-based integrated assessment tools and referral pathways to improve prevention, care coordination and recovery, including through better integration with mental health and psycho-social care provider and other networks.

Support community engagement/education and AOD-related stigma and discrimination reduction designed to; improve community awareness of the NHMRC Alcohol Guidelines and; harm reduction, reduced or healthier substance use and earlier help seeking for AOD concerns.

Continue to engage and work with primary and general practice, with a focus on building greater confidence and capacity to offer evidence-based screening, assessment, care and referral for client/patient with AOD concerns and promote awareness of, and access to, locally based specialised services and where appropriate shared care planning pathways to promote more effective referral and care, particularly for those with dual diagnoses and/or requiring out-of-region residential detox/rehab.

Participate in national dialogues planned to improve and collect meaningful First Nations AOD data, and monitor and review AOD data and health intelligence to inform joint planning and evaluation of services and support commissioned service providers to work within the stepped care approach.
